### **CJ takes suo motu notice of violence**

The Supreme Court has summoned top police and administration officials of Islamabad on Monday over use of force against lawyers and media people by law-enforcement agencies in the federal capital on Saturday. Notices to the interior secretary, chief commissioner, inspector general of police, deputy commissioner, duty magistrate and the senior superintendent of police were issued on Sunday after Chief Justice of Pakistan Justice Iftikhar Mohammad Chaudhry took suo motu notice of the matter. The capital saw pitched battles on the Constitution Avenue after lawyers were manhandled, baton-charged and tear-gassed during a demonstration against President Gen Pervez Musharraf's re-election bid when Election Commission officials were scrutinising nomination papers of presidential candidates...

Pakistani President Gen. Pervez Musharraf appointed a new head of Pakistan's top intelligence agency, the Inter-Services Intelligence (ISI), on Sept. 21 and promoted several two-star generals to three-star rank. Though they are part of an ongoing and routine reshuffle, these changes to the army's top brass come as Musharraf prepares to step down as military chief in an attempt to secure his re-election as president. The retirements and appointments of generals are designed to ensure Musharraf's continued control over the military. The new ISI chief, meanwhile, will have his hands full as he tries to deal with a growing desire to live under Islam in Pakistan...

### **Musharraf may face new legal battle**

Makhdoom Amin Fahim and Justice (ret'd) Wajihuddin Ahmad will challenge on Monday the Election Commission's decision to accept General Pervez Musharraf's nomination papers for the presidential election. Malik said that as chief of the army staff, the general could not contest the elections for the office of the president before completing two years after his retirement. He said that under the Constitution, the Supreme Court could postpone the presidential election for a specific period...

### **Pakistan topped list of arms purchasers in 2006**

WASHINGTON: Pakistan ranked first among all developing world recipients in the value of arms transfer agreements in 2006, concluding \$5.1 billion in such agreements, with India ranking second in agreements at \$3.5 billion, according to a report issued by the Congressional Research Service on September 26. Arms transfer agreements with the top 10 developing world recipients, as a group, in 2006 totaled \$22.2 billion or 77.1 percent of all such agreements with the developing world. India was the leading developing world arms purchaser from 1999-2006, making arms transfer agreements totaling \$22.4 billion during these years (in current dollars)...

### **SC moved for staying presidential elections, disqualification of president Musharraf for re-election**

ISLAMABAD: Presidential candidate Justice (Retd) Wajih ud Din Ahmad has challenged in Supreme Court (SC) the acceptance of nomination papers of president

general Pervez Musharraf by Chief Election Commissioner (CEC) for re-election and prayed the court to issue orders to stay the presidential elections. An identical petition has been filed by senator Sardar Latif Khosa on behalf of PPP. Through these petitions which have been filed under article 184 (3) of the constitution, the presidential candidates Makhdoom Amin Fahim and Justice (Retd) Wajih Ud Din Ahmad have taken the stance that the acceptance of general Pervez Musharraf nomination papers by CEC is unconstitutional decision. They contended general Pervez Musharraf does not qualify for contesting presidential elections under article 62 of the constitution and he is not eligible to take part in presidential polls in terms of his candidacy under article 63 of the constitution...

### **Govt approves Benazir indemnity package**

ISLAMABAD, Oct 2: The ruling Pakistan Muslim League (PML-Q) and its coalition partners on Tuesday endorsed a proposed legislation that would give the People's Party chairperson and some of her top confidants indemnity from court cases, sources said. The sources confirmed that a legislation either in the shape of a bill or a presidential ordinance had been prepared and sent to the president. It could become law within a day or two, they added. Through the new law, the sources added, the government would grant a general amnesty to all those who had held public offices between 1988 and 1999 and against whom corruption cases were pending. However, those who had been convicted by any court during the period would not benefit from the law. Former prime minister Nawaz Sharif, too, could get no benefit because of convictions...

### **Resignations revive focus on PPP moves**

ISLAMABAD, Oct 2: The presidential electoral college on Tuesday stood hugely impaired, beyond repair, as most opposition parties walked out of it by resigning from the National Assembly and provincial assemblies in a move that could force the government to try to retrieve an almost collapsed political deal with former prime minister Benazir Bhutto. The resignations by 85 opposition members from the 342-seat National Assembly, which is the core of the 1,170-member but 702-vote college, and by an unspecified number from three of the four provincial legislatures that form along with the 100-seat Senate the college, came just five days before the Oct 6 presidential election that opposition seeks to block. The move coincided with challenges filed in the Supreme Court by two rival candidates against President Pervez Musharraf's bid to be elected for another five-year term despite his alleged disqualifications and the naming of a new army chief to succeed him after the election...

### **"I will seek vote of confidence from next assembly"**

ISLAMABAD: President General Pervez Musharraf said on Wednesday he would seek a vote of confidence from the new National Assembly formed after general elections. Gen Musharraf, in an interview with Geo television, reaffirmed that he would take off his uniform before November 15 after being re-elected as president by the current assemblies. He said general elections would likely be held two months after November 15, probably in January. He said the resignations of opposition legislators would not affect the presidential election, as only 163 out of 1,170 members of the electoral college had resigned. The president said he did not deny that the United States had a role in talks between the government and Benazir Bhutto, and added that the PPP could help curb extremism in the country. He said power-sharing with the PPP was possible in the future political set-up...

### **PPP will resign on 5th if talks collapse**

LAHORE: PPP Central Executive Committee and Federal Council have decided to resign from the assemblies on October 5, a day prior to the presidential election, if the government negotiators do not take the party's proposals seriously. ### **Judge opposes re-election**

LAHORE: Justice Falak Sher, a judge on the nine-member Supreme Court bench that had dismissed on Sept 28 petitions challenging the holding of two offices by Gen Pervez Musharraf, has ruled that the general is not qualified to contest the presidential election. Justice Sher was one of the six judges on the bench who had declared non-maintainable the petitions filed by opposition politicians and lawyers. Three judges had dissented with the majority decision. Justice Sher gave his opinion on Gen Musharraf's qualification to contest the election in his detailed judgment released here on Wednesday " I am of the considered opinion that President Gen Pervez Musharraf is not qualified to contest the ensuing presidential election", he wrote while concluding his verdict...

### **Assembly will be dissolved on 8th: Fazl**

PESHAWAR, Oct 3: Leader of Opposition in the National Assembly Maulana Fazlur Rehman on Wednesday said that after the disposal of no-confidence resolution against NWFP Chief Minister Akram Khan Durrani on Oct 8, the latter would advise the governor to dissolve the assembly. Talking to journalists at the speaker's gallery after the adjournment of NWFP assembly session, he said that supporters of Gen Musharraf had created some legal complications and restrained Mr Durrani from dissolving the assembly, but these tactics would not validate the re-election of Gen Musharraf. He said President Musharraf had lost the game on moral grounds and he himself had destroyed his credibility by manoeuvring his unconstitutional re-election...

### **Deal is done**

ISLAMABAD: The months-long direct and indirect talks between President General Pervez Musharraf and PPP Chairwoman Benazir Bhutto concluded late Wednesday night, with both sides agreeing to the draft of a National Reconciliation Ordinance (NRO) as part of a power-sharing deal after the general election. The draft NRO proposes termination of all politically-motivated cases pending in Pakistan, as well as those initiated by the government in foreign countries, to the benefit of Benazir Bhutto. The provision to terminate cases in foreign countries was included in the NRO after she had refused to cooperate with President Musharraf. Final draft: PPP Senator Farooq Naik told Dawn News that Ms Bhutto had agreed to the final NRO draft. He said issues relating to Musharraf's uniform, Article 58(2b) and the bar on third-time premierships were still unresolved..

The bench asked the two sides to confine their arguments to the grant of interim stay...

### **Musharraf says time for full democracy**

ISLAMABAD: President General Pervez Musharraf on Thursday reiterated his commitment to doff his uniform between October 6 and November 15 this year, and said it was the right time for transition towards complete democracy, Dawn News reported. Musharraf said he had given in writing that November 15 was the last date for removing his uniform, adding that before that it is his option. He said that remaining in uniform beyond 2004 was necessitated by the domestic and regional environment at that time. He



said the biggest dictate for leaving the post of army chief was the legal and constitutional obligations. He said the challenges faced by Pakistan in the last few years such as the October 2005 earthquake, recent floods in Sindh and at the Sukkur barrage, proved the value of a president in uniform...

**US warned of reaction to unilateral military action**

WASHINGTON, Oct 4: Foreign Secretary Riaz Muhammad Khan has warned that any unilateral US military action in the tribal areas would have dangerous consequences both for Pakistan and the United States. Speaking to the Council on Foreign Relations in Washington, he said that such an action would weaken the government in Islamabad and be unpopular with the Pakistani public. His warning delivered at a gathering of top US policymakers, diplomats and think-tank experts follows a recent statement by former prime minister and opposition leader Benazir Bhutto that if elected she would allow US forces to operate in the tribal belt. Her statement has started a debate in the US media, with some American experts reiterating the demand for allowing US soldiers to strike alleged Al Qaeda and Taliban targets inside Pakistan...

**VIEW: Bhutto's route to power**

Four factors stand out among the causes of increased turbulence in Pakistan's politics. One, the presidential tenure of President Pervez Musharraf and that of the assemblies was coming to an end. It led to renewed hopes of a genuine change after several years of apathy and despair. Musharraf was at the apex of a system that controlled every facet of national life through functionaries whose true provenance was the army. Two, despite achievements in certain specific fields, his system of governance was no longer perceived by the people as either efficient or clean. Three, the empowerment of the media basically through the heroism and spirit of sacrifice of a new generation of journalists has become a factor of change. Four, a weightier factor emerged from the American need to avert another defeat in Afghanistan after the fiasco in Iraq. Washington could not take the risk of losing Pakistan, a key element in the US war in Afghanistan, to forces that may adversely affect the commitment of the Pakistan army to that war...

### **Editorial: On with the election**

By allowing the presidential election to go ahead as planned but barring the Election Commission of Pakistan from notifying its result till a ruling is given on petitions challenging President Musharraf's eligibility for the poll, the Supreme Court may have tried to strike a balance between the demands of the government and the petitioners. Clearly, Friday's ruling implies that the court needs more time to examine the petitions and wouldn't want to expedite its own hearing for the sake of the election. One member of the bench hearing the case had observed that the Constitution would not be violated if the presidential election were not held on Oct 6. A fair interpretation of Friday's decision by the Supreme Court would be that the government's request not to delay the election was considered to have substantial merit. It also puts the president in a somewhat odd position -- he knows that in all probability he should win today's presidential election but he has now been told that his victory could well amount to nothing if the ruling eventually ends up declaring him ineligible...
